Notice of Resource Consent Applications for Proposed Wind Farm





The Hauraki District Council and Waikato Regional Council have received applications for resource consents from Kaimai Wind Farm Limited.

The applications relate to a proposal to establish and operate a 24 turbine wind farm on 771 and 604 Rotokohu Road and 6356 State Highway 26, Paeroa.

The turbines are of a three bladed design, with seven turbines at a maximum height of 180m and seventeen at a maximum height of 207m. The application also involves the construction of a new 110kV sub-station including two new lattice transmission towers, construction of two internal 33kV overhead lines including double pole termination structures, 18.9km of internal roading, 24 turbine platforms, including crane pad, three turbine component laydown and construction equipment storage areas, replacement of eight existing culverts, underground cable network to collect the electrical output from each turbine, earthworks, one quarry and vegetation clearance.

The applicant has sought a term of 12 years to give effect to the resource consents.

Application for a district land use consent is made to the Hauraki District Council. Applications for regional land use consents and permits to divert stormwater (carry out earthworks and works on culverts) are made to the Waikato Regional Council.

The Hauraki District Council is project managing the processing and hearing of the applications. All submissions (including those on the applications to Waikato Regional Council) must therefore be lodged with Hauraki District Council.

If a hearing is required then the applications will be jointly heard by Hauraki District Council and Waikato Regional Council who will delegate their respective functions, powers and duties to a panel of independent hearing commissioners to hear and decide the applications.

Hauraki District Council

Notification of applications for resource consents under Section 95A of the Resource Management Act 1991.

Hauraki District Council has received an application (2018/873) from Kaimai Wind Farm Limited for resource consent to:

- Establish and operate a 24 turbine wind farm on 771 and 604 Rotokohu Road and 6356 State Highway 26, Paeroa.
- All activities and associated and ancillary structures including access road, turbine platforms, a 110kv substation, two lattice tower pylons, two 33kv overhead lines, and underground cable
- Earthworks excavation and fill and one quarry.

The application includes an Assessment of Environmental Effects.

Note: a number of resource consents are also being sought concurrently from the Waikato Regional Council. Decisions on the regional application will be made concurrently with the land use application made to Hauraki District Council.

Waikato Regional Council has received an application (APP139668) from Kaimai Wind Farm Limited for resource consents, being all necessary land use consents, discharge and water permits to authorise all activities associated with the construction, operation, maintenance and rehabilitation of the proposed wind farm, as listed below:

AUTH139688.04.01	Divert stormwater away from earthworks and overburden disposal sites in associa- tion with the development of the Kaimai Wind Farm Ltd project.
