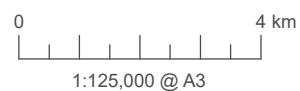

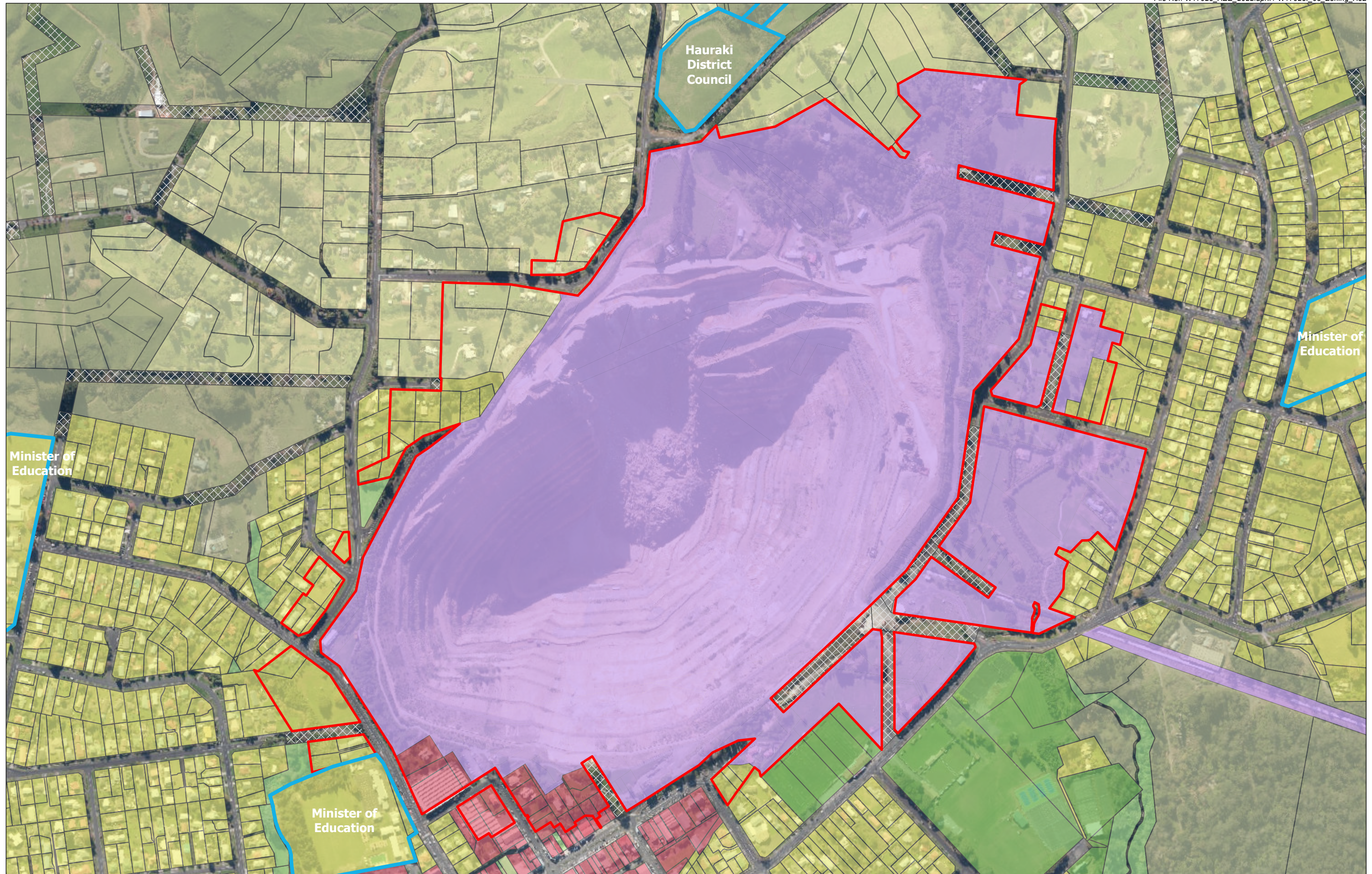
Waihi Urban Area and the Existing Martha Pit

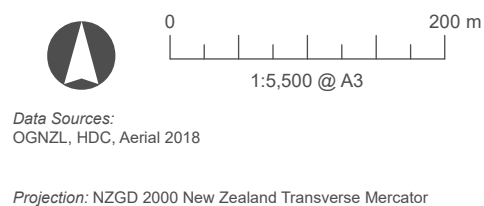

Existing District Plan Zoning, with Proposed Martha Mineral Zone

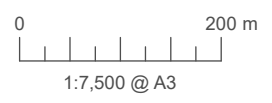

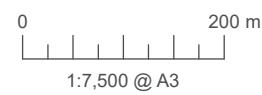

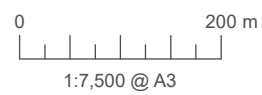

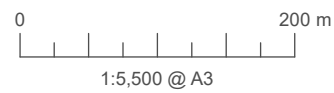

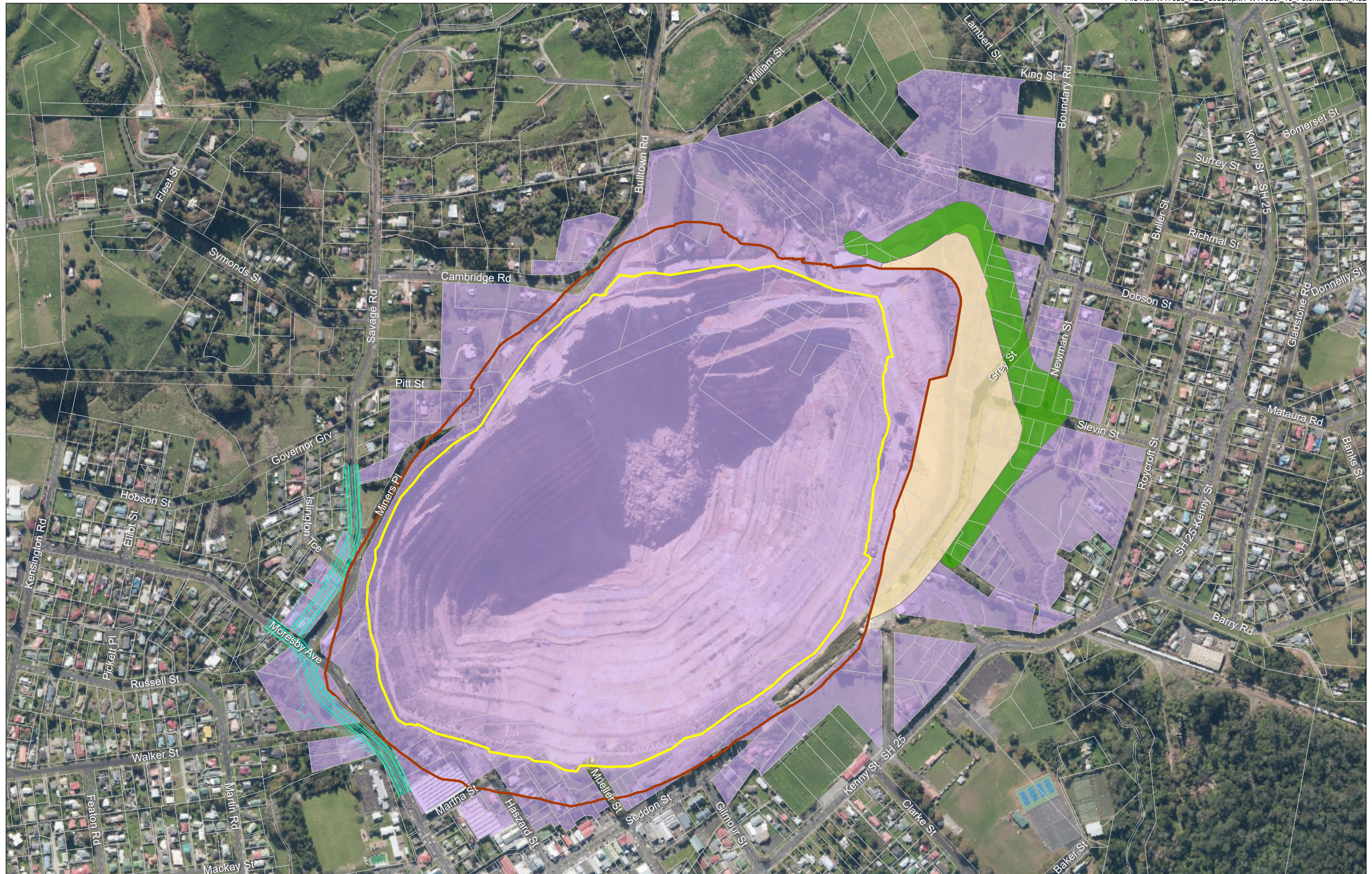

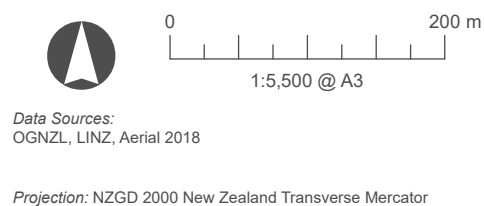
