

Enrolment Form for Ratepayer Electors



Please complete and return by 7 July 2016 for inclusion on Preliminary Electoral Roll

Enrolments for ratepayer electors can be made by or on behalf of:

- Parliamentary electors who are ratepayers within the region, district, or community but whose addresses as parliamentary electors are **outside** that region, district, or community;
- Legal entities such as companies, banks, or bodies corporate who are ratepayers in the region, district, or community;
- Persons such as joint tenants and tenants in common who are ratepayers in the region, district, or community.

The ratepayer elector and property information will be published in the electoral roll and other information provided may be included on that roll. (You may apply to the local authority at any time for the correction of that information).
