# Kaiaua - Request for Bottle Bank

A request has been received from members of the community asking that the bottle bank which was previously situated at the Boating Club reserve be returned to Kaiaua.

A discussion was held whether the bottle bank should be reinstated and relocated for a six week period over the peak holiday season to a more appropriate location due to the area being sensitive to iwi because it is a wahi tapu area. It was agreed that Crs Leonard and Swales be delegated to work with the community and council staff to find a suitable location for the bottle bank to be placed.

## Pioneer Park - Ground Levelling

A price to level the ground at Pioneer Park was requested by the Plains Ward Councillors.

The Community Services Department are responsible for the delivery of Council's Community Recreation, Community Facilities and some activities of Community Growth. A report on these activities will be presented to the Plains Ward Committee on a monthly basis.

# **Community Development**

#### Requests for Financial Assistance [CDV-30-100]

The Plains Ward Committee has \$4,579 from the 2014/15 term that was not allocated and a further \$11,213 for the 2015/16 term making a total of \$15,792 for discretionary grants for the current financial year.

Jillian O'Neill continues to manage the Ngatea- Live the Kiwi Dream Facebook and Web site by adding relevant information and monitoring and answering questions posted.

#### **Auckland Home Show 2016**

Another similar site has been booked at the 2016 Auckland Home show. The layout and marketing aim for next year's site is still to be finalised.

#### **Tradies Evening**

An evening was organised for Thursday 22<sup>nd</sup> September, hosted at Hammer Hardware Ngatea, thanks to Chris and Shelly, as an opportunity for local trades people to get informed as to what is going on at the Ngatea Northern Estate development and potentially further down the track. With 22 tradies attending and an additional number of councillors, council staff and real estate agents the turnout was considered very successful. Good informal discussion after the presentation took place in which two trades people indicated an interest in purchasing a few sections to build speculative homes on.

Bayleys will continue to work with them on furthering this interest in section purchases.
