This report has been written to provide Council the report that is required annually by the Ministry of Justice, under Section 199 of the Sale and Supply of Alcohol Act 2012. The report provides information and statistics for the year 01 July 2022 to 30 June 2023.

1 PURPOSE | TE ARONGA

Section 199 of the Sale and Supply of Alcohol Act 2012 requires a report to be submitted each year from the District Licensing Committee (DLC) to the Alcohol Regulatory and Licensing Authority (ARLA) covering the period 01 July to 30 June each year.

2 BACKGROUND | TE KŌRERO Ā MUA

Overview of DLC Workload

Membership of the Hauraki District Council District Licensing Committee has one addition since last local government election. The following serving members:- Councilor Paul Milner, the Chairperson, Councilor Carole Daley who is the Deputy Chairperson, Councilor Rino Wilkinson, and the five independent persons Mary Carmine, Denis Taylor, John Goodman, Brent Holmes and Ross Murphy.

There were 6 hearings for the Committee to preside over.

The DLC Chairperson was kept busy reviewing and approving all other uncontested license applications throughout the period.

One application has been referred to the Authority – DLC Decision to refuse renewal of Thirsty Liquor Paeroa

DLC members have had the opportunity to undertake further training online provided by the DLC Network. The chairperson has also been part of a DLC Advisory Group set up to provide feedback to the Ministry of Justice regarding Alcohol Reforms that Parliament is set to consider.

Controlled Purchase Operations (CPO)

A CPO is an operation that involves Police, Ministry of Health and Council, to complete visits to licensed premises in order to test their policy and processes regarding the Sale and Supply of Alcohol. In addition were two minors (volunteers).

An operation was undertaken on 14 April 2023, where a briefing was undertaken at the Paeroa Police Station. Minors were briefed to enter targeted premises, and would not have any form of identification or personal cash on them. An attempt would be made by the minors to make a purchase of alcohol at the premises. If no successful purchase was made, the minors would leave the premise and return to the vehicle (of which there was a Police Officer, Environmental Health Officer and a Ministry of Health Officer). If a successful purchase was made then certain processes were undertaken.

Ten premises were visited in this operation, with two (Off Licence) failing. Prosecution would be undertaken by the Police against these two premises. The outcome of the failures are yet to be determined by ARLA.

Local Alcohol Policy

Council's Local Alcohol Policy 2016 (adopted 01 July 2016), was reviewed 31 August 2022, and will be due for review again by 31 August 2028. There were no changes made to the Policy as part of the August review.

Covid 19

In light of the COVID-19 pandemic, the Government made a temporary law change (Immediate Modification Order) to modify the requirements relating to licence applications and renewals under sections 103 and 129 of the Sale and Supply of Alcohol Act 2012.

This modification is no longer in place.

Manager's Certificates

Manager's Certificate Questionnaires continue to be used for all new applications and for any applications for renewal where the applicant was not first registered with this Council. Forms 17 and 19 have recently been updated. Form 17 now requests photo ID. Both forms also now request a copy of any current visa and passport, if the applicant is not a NZ citizen or permanent resident. This continues to be the case.
