

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by **Paeroa Pipe Bands Tattoo Committee Incorporated** pursuant to s. 138 of the Act for a Special Licence in respect of premises situated at King Street, Paeroa, known as Paeroa Domain

DECISION

1. I have before me an application by **Paeroa Pipe Bands Tattoo Committee Incorporated** for a special licence in respect of premises situated at King Street Paeroa.
2. The inspector has filed a report on the application and does not oppose the granting of the special licence. The Police have offered no opposition to the granting of the special licence. MOH have offered no opposition to the granting of the special licence
3. FENZ did not offer any opposition to the application.
4. The application is for Paeroa Pipe Bands Tattoo Committee Inc on the 14th February 2026.
5. The following conditions will apply to the licence:
 - a) Drinking water is to be freely available to customers at the bar at all times the bar is operating.
 - b) Alcohol may be sold, supplied and consumed under this licence only on the following day and during the following hours:

Saturday the 14th of February 2026 from 11.00am to 9.00pm
 - c) When alcohol is available for sale and supply, the following must be available:
 - i. A minimum of three types of substantial food.
 - ii. A reasonable range of non-alcoholic drinks.
 - iii. At least one type of low alcohol.
 - iv. Information regarding and assistance with alternative forms of transport.

- d) Margaret Taiawa and Kamaljit Singh who hold a current managers certificate have been nominated to manage the conduct of the sale of alcohol under this Special Licence are required to be present for the duration of the licensed hours.
 - e) No intoxicated persons may be allowed to enter or to remain on the premises.
 - f) The alcohol management plan that was submitted with the application must be complied with.
 - g) The following must be prominently displayed adjacent to every point of sale:
 - i. Appropriate signage regarding the restrictions on the supply of alcohol to minors and intoxicated persons
 - ii. This special licence
 - h) The whole of the Bar area as depicted on the map of the Paeroa Domain on Willoughby Street, Paeroa is designated as a **RESTRICTED** area.
6. I am satisfied that the nominated persons will manage the conduct of the sale of alcohol pursuant in accordance with section 213 (1).
7. I am satisfied as to the matters to which I must have regard in s.142 of the Act, and I am satisfied that this application meets the purpose and object of the Act. Accordingly, I grant the special licence which may issue immediately.
8. I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.
