The Franklin District Plan was approved in part by the Franklin District Council by resolution passed at its meeting held on the 2nd of December 1999.

This approval is with the consent of the Environment Court under clause 17(2) of the First Schedule to the Resource Management Act 1991.

There are outstanding references relating to the Tutaenui (North Pukekohe Hill) Catchment Area. This area is indicated on the map overleaf. The provisions of the District Plan as they relate to this area are not yet operative. Reference must be made to the Transitional District Plan provisions as they relate to that area until such time as the outstanding references are resolved.

The Franklin District Plan shall become operative from 9.00am on the 29th day of February 2000.

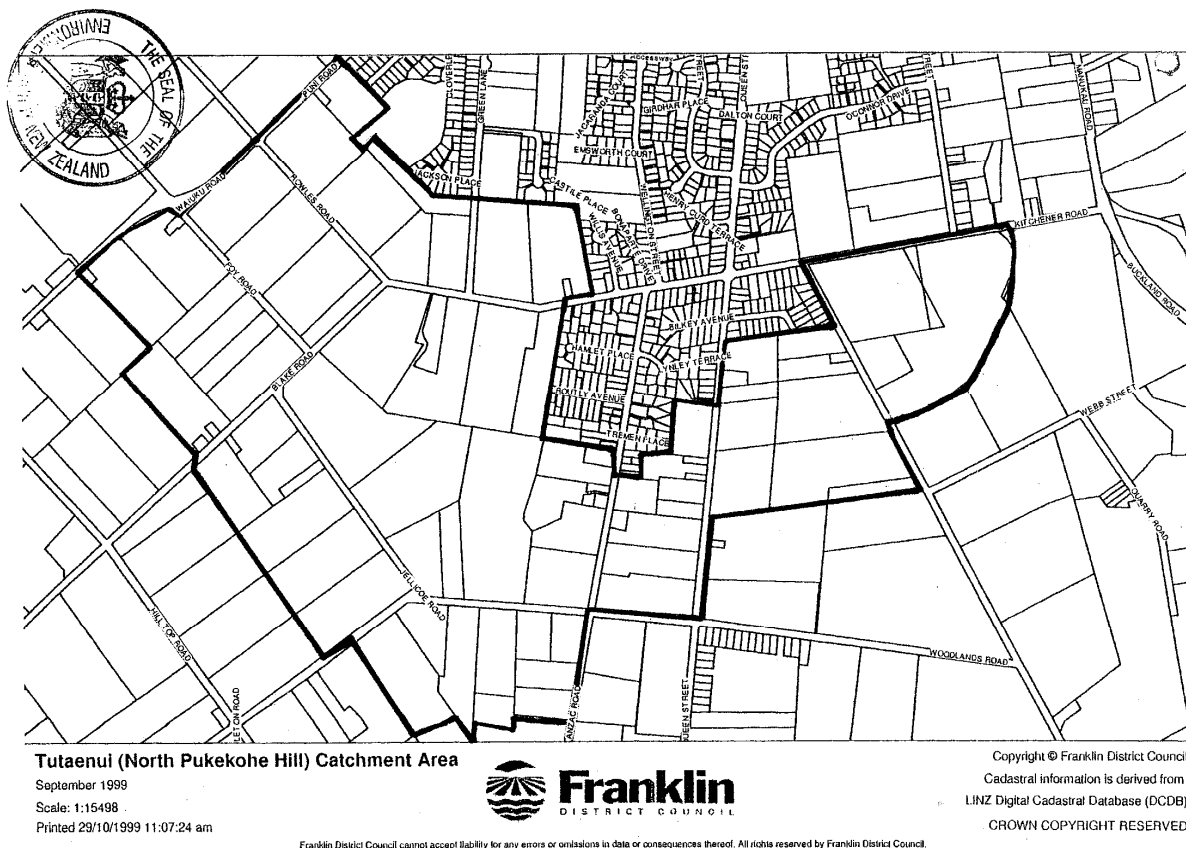
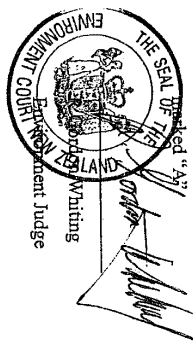
