General Store, Waitakaruru (The Country Store)

History: The large Four Square Store was originally the Royal Harrison Hotel at Kuaotuna on the Coromandel Peninsula. It was dismantled and brought by barge to Waitakaruru in about 1916. The Peters' tin shed, first post office building (1914-1918) opposite the site of the ex-hotel, was relocated next to the hotel and used as a garage for the shop. The store was run by Mr and Mrs Siward until 1920 when Mr and Mrs Tom Elliot took over. It was sold again in 1944, although the grocery store continued until 1998. It was vacant for a couple of years before being purchased by Susan Lowe. It now operates as the "Country Store", a craft outlet and tourist store.
