**History:** A post office was established in 1906 in William Coxhead's house at Bathurst's Corner. In 1909, the post office was moved to a tin shed on I. Haley's farm and in the following year Haley took over as post master. In 1911, the post office shifted to an extension built onto William Peters' house on the Front Miranda Road. Peters also had a store at Waitakaruru itself, about a mile from the house, and letters were taken to the store. In 1914, the store became the Waitakaruru Post Office proper. ### Waitakaruru Post Office

was appointed post master in 1918, followed soon after by Miss S. Stretton. The post office was shifted to a separate building by the wharf close to the bridge over the Waitakaruru Stream. A new post office was built in 1934 and the old building was shifted to the school in 1935 for use as a dental clinic.

The post office was closed in 1988 and is now a private residence. The telephone exchange building is still attached to the house.
