## NZ Co-op Cheese Factory, Waitakaruru

(Reynolds-Spragg Co.) had built seventeen factories by 1916 including three on the plains at Netherton, Huirau Road and Kopuarahi. The Thames Valley Co-Op Dairy Co got into financial difficulty after the construction of the Waitoa milk drying plant. In 1919, financiers encouraged the formation of the NZ Co-operative Dairy Co by merging the Thames Valley Co-Op Dairy and Waikato Valley Co-Op Dairy.

In 1924, the Thames Valley Company went into voluntary liquidation, with a new factory at Ngatea almost completed. The new factory retained the Thames Valley name, although it was operated by the NZ Dairy Association. In 1928, a factory was built at Waitakaruru following pressure from the local farmers and possible interest in a cream receiving station at Waitakaruru by the Te Aroha Dairy Company. The factory was built on land set aside by the Crown for a factory site. The Waitakaruru Cheese Factory opened on the 11th December 1928. By 1953, it was the largest singe-shift cheese factory in New Zealand. It closed in 1956 and all milk was carted to Kerepehi. The factory was purchased by Arthur Yates and Company for conversion to a peat processing and blueberry packing plant. In 2001, Yates closed the operation at Waitakaruru. The complex was purchased by R.E. Thompson Ltd and Baker Agricultural Contractors.

By 1953, a factory hostel was built to house the workers. The factory was converted to a casein factory in 1955. The Hostel was still used as a hall for annual meetings and, for a time, was a hair dressing salon. In 1967, a local Playcentre was formed, based in the hostel. The Playcentre then moved to a room in the Primary School before moving to a new building between the hall and the domain in 1977/8.


