Parochial District of Hauraki Plains. The church was dedicated on Trinity Sunday 7th June 1923. Rev J. M. Beaufort was the first vicar and boarded with the Bell family until a vicarage was built in 1925. With improved roading and transport, Ngatea became the focal point for various parishes in the district. The vicarage was transferred to Ngatea in May 1958. Many of the other small village churches were closed and became private residences. Others were dismantled or used for other community interests. The church building was vested in the ownership of the Hauraki District Council on behalf of the community by the Hauraki Plains Co-Operating Parish in the 1990s. The free gifting of the building was on the basis that it should not be disposed of by the community within ten years of acquisition. It was to be used by the community for community purposes. In 2003, it was sold to B J Downie.
